CONSENT AND ACKNOWLEDGMENTS IN TERMS OF THE PROTECTION OF PERSONAL INFORMATION ACT 2013 (POPI)

- 3. How will Metrobus process personal information?

Metrobus will only collect personal information for the purpose as stated above. Information will be collected in the following manner:

- •from service providers who provided with services or goods to Metrobus;
- •from Metrobus own records relating to previous supply of services or goods; and/or
- •from a relevant public or equivalent entity.
- 4.To whom will personal information be disclosed?

The personal information may be disclosed to other relevant public or other entities on whose behalf we act as intermediaries, other third parties referred to above in relation to the purpose or who are sources of personal information,

5. Consent and Permission to process personal information:

Scope of work

The objective of this tender is to appoint a suitably qualified service provider for the repairs, maintenance and replacement of air-conditions and related components at Metrobus buildings and depos.

Metrobus currently has four depos namely, Milpark Depo, Village main depo Roodepoort depo, Randburg depo and Fordsburg depo. Metrobus also has Offices namely Head office, Ghandi square office and Eldorado park satellite offices. The scope of work is not limited to faultfinding's repairs, replacing, repairs maintenance/servicing of air cons twice annually on as and when required basis.

The Service provider will be expected to keep record on the maintenance of all air cons and advice Metrobus on the replacement for new aircon on a monthly basis.

The successful service provider will be expected to repairs maintain and replace air-conditioners and related components at Metrobus buildings and depos on an as and when required basis for a period of 12 Months limited to a budget of R750 000 as per the Supply chain management regulations.

The service provider should have enough resources and workforce to respond to emergency repairs, working after hours and tight deadlines.

NB! This request for quotation will be based on rates, and maintenance as cost will be subject budget availability. Since this will be a moving contract the extent of repairs will be determine as and when required, however for the purpose of evaluation, the pricing schedules that will be used is the one outlined above on the pricing schedule. Quantities are also an estimate and are for the purpose of evaluation.

Evaluation Criteria

In line with the Preferential Procurement Regulations, 2022, all procurements above R30 000 will be evaluated on **80/20** preference point system with the following specific goals:

- a) an EME or QSE which is at least 51% owned by black people = 10 points
- b) an EME or QSE which is at least 51% owned by black people who are women = 5 points
- c) an EME or QSE which is 51% owned by black people who are youth = 5 points.

A maximum of 20 points may be awarded to a tenderer for the specific goal specified for this RFQ. The points scored for the specific goal will be added to the points scored for price and the total will be rounded off to the nearest two decimal places.

The highest scoring bidder would be recommended, however Metrobus reserves the right not to award it to the highest scoring bidder.

Points can be claimed by ticking the appropriate box below: Metrobus will verify the information on the National Treasury's CSD report. Failure to claim points may results to zero (0) point being awarded.
